Dear President Trump,

We write to you today with deep concern regarding your Administration's actions to undermine the United States Agency for International Development (USAID), thus eliminating programs and projects that directly support women and girls worldwide.

USAID programs to address women in developing countries were first authorized in 1973 under the "Percy Amendment" as part of the Foreign Assistance Act of 1961, as amended, which necessitates that foreign assistance funds work to integrate women into the national economies of developing countries<sup>1</sup>. This enacted legislation recognizes gender inequality as a global policy issue and supports efforts focusing on healthcare, education, and policy improvements. USAID works to tackle the underlying causes of gender inequality and subsequent gender-based violence (GBV), strengthen legal protections for victims, and ensure survivors can access justice, security, and economic resources. These efforts contribute to the prevention of violence and the development of stronger, more sustainable and empowering communities<sup>2</sup>.

Countries in which USAID operates are experiencing turmoil, including violent organized crime, widespread corruption, and the growing displacement of women and families. USAID supports health, education, and governance programs to support women and girls around the world. In fact, this work has enjoyed longstanding bipartisan support, including support from the White House during your first term. Despite long-standing bipartisan support for USAID initiatives that fight violence against women and girls, the proposed elimination of USAID and its funding would roll back years of progress across the globe and violate U.S. law.

The repercussions of these actions will be felt in the form of increased maternal and child mortality, reduced access to education, economic hardship, and heightened vulnerabilities to gender-based violence and exploitation of women.<sup>3</sup> At a time when women and girls are disproportionately affected by global conflicts, climate crises, and economic instability, continued programmatic and financial support in conflict zones such as Afghanistan, Syria,
